The Payson Pro Rodeo Committee Code of Ethics & Rules of Conduct is a necessary standard governing the behavior and actions of our Rodeo Committee Members and Volunteers. We are confident that adherence to them will result in a more enjoyable experience for all. Failure to adhere to the Codes of Ethics and Rules of Conduct will result in a Board of Directors review of your participation.

- 1. Volunteers must be courteous, respectful, and professional in their dealings and communication with each other, PPRC Committee Members, Contract personnel, and the General Public, at "all" times. Absent this ability, Volunteers should avoid interaction with others. Any violations of this type should be reported to the Board of Directors in writing for review.
- 2. Any Volunteer working during an event where the Payson Rodeo Committee, Inc. has a special event liquor license issued by the State of Arizona, shall not consume any alcohol or be impaired in any way before or during the special event.
- 3. If attending a PPRC Meeting, Volunteers must respect "Roberts Rules of Order" during all meetings.
- 4. Dress Code: If working in the Arena, Volunteers must wear a long sleeve shirt, jeans, sturdy boots, and a western style cowboy hat. All others must wear conservative western style clothing and sturdy closed toe footwear to support the Western Family Lifestyle. No tank tops. This is a family oriented event.
- 5. As a Volunteer, you have a duty to advise the Payson Rodeo Board of Directors of any activity that is believed to be detrimental to the best interest of the Payson Pro Rodeo Committee. Proof of any type of this activity must be presented to the Board of Directors in writing.
